# A. Background and Context

The project "Women on the Green Path", (the Project) aims to promote women's economic empowerment in the green and circular economy in The Mediterranean region. The green and circular economy has become a significant focus in the region, with the potential to drive sustainable development and climate resilience. However, several challenges hinder the full participation of women in this sector, including lack of resources, limited access to funding, and prevailing negative social norms.

The project is implemented in Tunisia, Jordan, and Morocco, focusing on building the capacities of organizations supporting women entrepreneurs, enhancing their role in driving sustainable growth, and advocating for gender equality in the transition to a green economy. WGP supports policy engagement, capacity building, and technical assistance for women entrepreneurs and MSMEs working in green sectors, contributing to inclusive and sustainable economic development in the region.

CAWTAR, in collaboration with REMESS, Edama and MedWaves, the UNEP/MAP Regional Activity Centre for SCP has launched this initiative to contribute to the creation of an enabling environment for women entrepreneurs in the green and circular economy, fostering their growth, sustainability, and leadership.

This action is carried out with the support of GIZ on behalf of the Federal Ministry for Economic Cooperation and Development of Germany, the Agencia Española de Cooperación para el Desarrollo (AECID), and the Union for the Mediterranean Secretariat (UFMS).

#### **B.** About the WGP consortium:

The **Centre of Arab Women for Training and Research (CAWTAR)** is a leading regional organization dedicated to promoting gender equality, women's rights, and economic empowerment in the Arab world through research, training, and advocacy initiatives. CAWTAR plays a key role in fostering the inclusion of women in economic

development, particularly within green and circular economies.

The **Edama Association for Energy, Water, and Environment**, based in Jordan, focuses on promoting sustainable practices in energy, water management, and environmental protection. Edama advocates for the adoption of green technologies and supports the development of sustainable business models, particularly in the context of a green economy.

The **Réseau Marocain de l'Economie Sociale et Solidaire (REMESS)** is a Moroccan network that promotes social and solidarity-based economies. REMESS plays a critical role in advancing gender equality and supporting women entrepreneurs in green and circular economy sectors through capacity-building, advocacy, and creating sustainable business opportunities.

**MedWaves, based in Barcelona,** is the UNEP/MAP Regional Activity Centre for Sustainable Consumption and Production (SCP). The Centre develops its activity under the Mediterranean Action Plan (MAP) for the protection and development of the Mediterranean basin, an organisation belonging to the United Nations Environment Programme (UN Environment).

MedWaves provides knowledge, training, advice and networking opportunities to governments, businesses, entrepreneurs, financial agents and civil society organizations to adopt eco-design and eco-innovation as strategic approaches to boost businesses competitiveness in the market.

## **Objective of the Call:**

The objective of this call for applications is to identify and select 45 representatives of Business Support Organizations (BSOs) in Tunisia, Jordan, and Morocco (15 per country) to participate in a Training of Trainers (ToT) program under the Women on the Green Path (WGP) project.

This training will enhance the capacity of BSOs to integrate gender-responsive approaches and sustainable practices into their support services for women entrepreneurs. The program aims to equip BSOs with the necessary tools, knowledge, and methodologies to promote the green and circular economy, ensuring that women-led businesses are at the forefront of sustainable development in the region. Through this initiative, BSOs will be empowered to coach and mentor women entrepreneurs, contributing to both gender equality and environmental sustainability in their countries.

## **Eligibility:**

· Be a representative of a BSOs<sup>1</sup> operating in Tunisia, Jordan, or Morocco.

· Representatives who hold leadership or training roles within the organization.

Note: Persons who have received the same training program as the current call (MedWaves/SwitchMed Methodology) are not eligible to participate in this application process, as the goal is to enhance the pool of experts and improve the skills of ecosystem stakeholders.

These are entities that provide a range of services and resources to support businesses and entrepreneurs in various stages of development. Their services typically include offering technical assistance, mentoring, and access to finance, training, and networking opportunities. BSOs can take different forms, such as cooperatives, business-women networks, incubators, accelerators, or government agencies dedicated to economic development.

Additionally, the training will equip BSOs with knowledge and tools to develop tailored products and services that support women entrepreneurs in adopting sustainable and inclusive practices, fostering their role in the green transition.

- · Alignment of the organization's mission with the goals of the Women on the Green Path (WGP) project.

### **Experience and Expertise of the Applicant (30%):**

• Demonstrated experience in supporting women entrepreneurs, particularly in green and circular economy sectors.

• Track record of providing training, mentorship, or capacity-building services to small and medium enterprises (SMEs).

# **Geographical Reach and Impact Potential (20%):**

• The BSO's geographical coverage within their respective country, with priority given to organizations that have the potential to impact a wide range of women entrepreneurs, especially in rural or underserved areas.

# Role of the Applicant within the BSO (20%):

 The role and responsibilities of the nominated representative within the organization, with preference given to those in leadership or training positions who can directly implement and cascade the knowledge gained through the ToT program.
